## ORDINANCE No. 150933

An Ordinance transferring \$4,470 within the General Fund from General Fund Operating Contingency to the Office of General Services for part-time accounting support, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That during the past two years, the Office of General Services has assumed the additional responsibility for providing accounting services for the Morrison Park East and West Parking Garages, Records Management Division, Public Service Building, City-County Justice Center, and Purchasing and Stores Division.
- 2. That these actions have greatly increased the work load of the Office of General Services.
  - 3. That additional accounting support is required to effectively carry out these functions.
  - 4. That appropriations in the amount of \$4,470 should be transferred to fund an accounting assistant on a 30 hour per week basis through June 30, 1981.
