

ORDINANCE No. 151090

An Ordinance creating one position of Human Resources Specialist III (7457) and one position of Human Resources Coordinator I (7460) within the Human Resources Bureau, Training and Employment Division, AU 682, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Training and Employment Division is in need of one Human Resources Specialist III position to assist in the development of the Targeted Jobs Demonstration Program, Private Industry Council programs and related private sector programs.
2. One position of Human Resources Coordinator I is also required by TED to coordinate the activities of the Multi-jurisdictional Private Industry Council under Title VII of CETA, the Private Sector Initiative Program.
3. These positions have been classified by and have the approval of Civil Service.
4. Funds for salary and benefits for these positions are available within The FY 1980-81 Budget, AU 682.
5. It is therefore appropriate that the positions of Human Resources Specialist III and Human Resources Coordinator I be created.

NOW, THEREFORE, the Council directs:


- a. One (1) Human Resources Specialist III (7457) position and one (1) Human Resources Coordinator I (7460) position are created within the Human Resources Bureau, Training and Employment Division, AU 682, at the salary rate in accordance with the current compensation plan of the City of Portland.

Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance will result in unnecessary problems in the administration of the CETA programs; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
