ORDINANCE NO. 150938

An Ordinance authorizing the purchasing agent to call for bids for the provision of maintenance and repair service on two (2) Carrier water chillers located at the Portland Civic Auditorium for a period of sixty (60) months, authorizing a contract with the lowest responsible bidder as designated by the Council, authorizing the drawing and delivery of warrants, and declaring an emergency.

Section 1. The Council finds:

- 1. That two (2) Carrier Model 19DA-131 Hermetic Centrifugal Chiller units located at the Portland Civic Auditorium require periodic maintenance.
- 2. That the previous agreement for maintenance and repair services expired September 30, 1980.
- 3. That a quarterly purchase order for interim maintenance and repair services expires January 31, 1980.
- That it is now appropriate to solicit competitive bids for these services.
- 5. That funds are available in the FY 1980-81 Civic Auditorium Fund.

NOW, THEREFORE, the Council directs:

a. The Purchasing Agent shall advertise for bids using plans and specifications filed in his office and in the event that no satisfactory bid is received, shall readvertise on the same basic specifications until a satisfactory bid is received.

A contract is authorized with the most favorable bidder b. as designated by the Council.
