An Ordinance transferring appropriation in the amount of \$5,250 within the General Fund from General Operating Contingencies to the Bureau of Personnel Services, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Portland Fire Bureau has developed a cadet training program creating 15 positions aimed at bringing minority group individuals into a career in the Oregon Fire Service.
- Funds for providing pre-employment physicals for this program were not included in the Bureau of Personnel budget. It is anticipated that twenty (20) pre-employment physicals at approximately \$150 each will be required to fill the 15 positions.
- 3. Higher than anticipated rejection rates due to medical pre-employment screening has resulted in an over-expenditure in medical costs within the Bureau. Funds for an additional fifteen (15) examinations are requested.
- 4. The transfer of \$5,250 is required within the General Fund from General Operating Contingencies to the Bureau of Personnel Services to provide funds for thirty-five (35) pre-employment physicals.

NOW, THEREFORE, the Council directs:
