**AMENDMENT No. 1 to**  
**INTERGOVERNMENTAL AGREEMENT No. 30005637**  
**FOR**  
**AT-RISK YOUTH FOR OUTDOOR MAINTENANCE**

This Amendment No. 1 amends Intergovernmental Agreement (IGA) No. 30005637 dated 1<sup>st</sup> day of July, 2016, by and between Multnomah County Department of Community Justice, Juvenile Services Division, here after called "County," a government agency of the State of Oregon, and the City of Portland, a municipal corporation of the State of Oregon ("City") by and through their duly authorized representatives. This Amendment may refer to County and City individually as a "Party" or collectively as the "Parties."

This Amendment is authorized by City Ordinance No. \_\_\_\_\_.

The Effective Date of this Amendment is May 31, 2021. The purpose of this Amendment is to extend the (IGA) through June 30, 2026 and add \$375,000 to pay for the additional years of service.

The IGA has not been previously amended.

The Parties agree to Amend the IGA as follows:

1. The IGA not-to-exceed amount of \$375,000 is increased by \$375,000 to a new total not-to-exceed amount of **\$750,000**.
2. The Term is extended from 6/30/2021 to 6/30/26, unless terminated sooner under the provisions of the IGA.
