ORDINANCE No. 91646

An Ordinance correcting the description in Ordinance No. 91,023, passed by the Council January 12, 1950, accepting certain property for the opening and extension of N.E. Holman Street and N.E. 41st Avenue, and declaring an emergency.

The City of Portland does ordain as follows:

Section 1. That the following described parcel of property be and is hereby accepted for street purposes:

Beginning at a point in the north line of the Isaac Hermison D.L.C., which point is 50 feet west of the intersection of the north line of the Isaac Rennison D.L.C. and the east line of Section 13, T.1 N., R.1 E., W.M.; thence west following the north line of the Rennison D.L.C. 273.41 feet to a pipe; thence southerly and parallel to the east line of said Section 13, 170.9 feet to a point in the south line of vacated N.E. Holman Street (vacated by Inance No. 91468 April 12, 1950); thence easterly along the south line of said vacated N.H. Holman Street to the northwesterly corner of Lot 11, Block 2, Ainsworth Park, an addition to the City of Portland; thence northerly parallel to the east line of said Section 13 to a point which is 60 feet southerly of the north line of said Rennison D.L.C., when measured at right angles thereto; thence easterly parallel to and 60 feet distant from the north line of said kennison D.L.C. to a point in the west line of W.E. 42nd Avenue, extended northerly from the south; thence northerly along this extension of the west line of N.H. 42nd Avenue to a point in the north line of said vacated N.E. Holman Street; thence southwesterly along the northerly line of said N.E. Holman Street to the west line of N.E. 42nd Avenue, as now laid out; thence northerly along the west line of N.B. 42nd avenue to the point of beginning.

This deed is executed for the purpose of correcting that certain deed dated December 7, 1949 and recorded January 17, 1950 in Book 1381 at Page 555, Multnomah County Deed Records.

Section 2. That the City Auditor be and he is hereby directed to have the deed for street purposes as described in Section 1 of this ordinance placed on record and a copy of said ordinance forwarded to the County Assessor.

Section 3. Inasmuch as this ordinance is necessary for the immediate preservation of the public health, peace and safety of the City of Portland in this: To avoid any unnecessary delay in the widening and extension of these proposed streets; therefore, an emergency is hereby declared to exist and this ordinance shall be in force and effect from and after its passage by the Council.
