An Ordinance granting a permit to the American Rhododendron Society to hold its 1981 Annual Plant and Flower Show and sale on the Rhododendron Island, subject to certain conditions, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 91847, passed by the Council June 15, 1950, granted a revocable permit to the American Rhododendron Society for the use of the Rhododendron Island as a rhododendron test garden.
2. Allen van Veen, 750 N.W. 107th Avenue, Portland, Oregon 97229, Chairman of the 1981 Show, requests permission for the Portland Chapter of the Rhododendron Society to conduct its annual exhibition May 9 and 10 and Plant Sale April 11, May 9 and 10, 1981 on the premises from 10:00 a.m. to dark at the Crystal Springs Rhododendron Garden, for the purpose of raising funds for operation, maintenance and new construction in the test garden.
3. The show is in the public interest, and it has been recommended by the Superintendent of Parks and approved by the Commissioner in charge that such permit be granted.

NOW, THEREFORE, the Council directs:

1. The Portland Chapter of the American Rhododendron Society, by Allen van Veen, hereby is granted a permit to conduct a plant and flower show on the Rhododendron Island on May 9 and 10 and a plant sale April 11, May 9 and 10, on the premises from 10:00 a.m. to dark, subject to the following conditions:
 - a. The admission charge shall not be more than \$1.00 per person, with children 12 years of age and under admitted free.
 - b. Net proceeds of the show and sale from all sources after payment of all expenses shall be used for operation, maintenance, and new construction in the test garden.
 - c. A complete report of receipts and expenditures of said show and sale shall be made to the Commissioner in charge of the Bureau of Parks on or before August 1, 1981.

ORDINANCE No.

Section 2. The provisions of this ordinance shall not be effective until a certificate of insurance approved as to form by the City Attorney has been filed with the City Auditor, affording protection for the City of Portland, its officers, agents and employees, against any claim arising out of the event as set forth in Section 1 hereof, in the single limit amount of \$300,000 per occurrence for all claims.

Section 3. The permit provided by this ordinance shall not become effective until permittee shall have filed with the City Auditor, in form approved by the City Attorney, a document in writing accepting the terms and conditions of this ordinance.

Section 4. The Council declares that an emergency exists because delay in enactment of this ordinance would cause unnecessary difficulty in making arrangements for the event; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
