ORDINANCE NO. 151353

An Ordinance transferring \$70,000 within the General Fund from General Fund Operating Contingency to the Bureau of Facilities Management for the purpose of rebuilding the restroom in Lownsdale Square, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. It is necessary that the Lownsdale Square restroom, demolished in an explosion on April 23, 1980, be reconstructed.
- 2. The restroom designed by the Bureau of Facilities Management and Parks and Recreation is an appropriate replacement in keeping with the historic motif of the original structure and providing handicapped access; upgraded for improved user safety and vandalism resistance.
- 3. The proposed restoration design was reviewed and approved by the City Historic Landmarks Commission.
- The cost of the restoration is estimated at \$70,000, which has been determined by the Bureau of Risk Management to be eligible for reimbursement by insurance, in an amount as yet undetermined.
- 5. It is necessary to transfer appropriations in the General Fund from General Fund Operating Contingency in the amount of \$70,000 to the Bureau of Facilities Management for project expenses not included in the FY 1980-81 budget.

ORDINANCE No.

NOW, THEREFORE, the Council directs:

a. The FY 1980-81 City budget is hereby amended by the transfer of appropriations within the General Fund as follows:

Section 2. The Council declares that an emergency exists, because the appropriation is needed immediately to allow for an estimated twenty (20) weeks to obtain the plumbing fixtures order; therefore, this Ordinance shall be in force and effect from and after its passage by Council.


