## ORDINANCE No. 151373

An Ordinance authorizing an amendment to Contract No. 18045 between the City of Portland and URS Company to provide engineering services for the Lents Street Improvement Project (District 1), increasing the maximum amount of compensation for inspection services from \$58,600.00 to \$65,005.00, authorizing payment, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- The contractor for the Lents 1 street construction project was on the project site 45 days beyond the original contract time in order to complete some major work items and many minor work items.
- 2. It was necessary to provide construction inspection services during the 45 day period.
- There are sufficient funds in the project budget to provide for these additional construction inspection services (159.210).

NOW, THEREFORE, the Council directs:

- a. The Auditor and the Commissioner of Public Works are hereby authorized to sign on behalf of the City the amendment to Contract No. 18045, such amendment to be in accordance with Exhibit 1, attached to the original of this ordinance, and by that reference made a part hereof.

Section 2. The Council declares that an emergency exists so that the contract can be completed at the earliest practicable date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
