ORDINANCE No. 151388

An Ordinance amending Title 32, Signs, of the Code of the City of Portland, in order to revise Chapter 32.20 Detailed Regulations, Section 32.20.240, Minimum Requirements for Structural Features, providing authority to require that welders doing work within the scope of the sign industry be certified in accordance with American Welding Society Standards, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds.

- 1. That the City of Portland does not have regulations requiring that welding done within the scope of the sign industry be performed by welders certified in accordance with American Welding Society Standards.
- 2. That without such regulations, there exists a potential for danger to the citizens of the City of Portland.
- 3. That the Bureau of Buildings as a part of this implementing process has consulted with the sign industry regarding this proposed regulation and the procedure for testing and registration of welders.

NOW, THEREFORE, the Council directs:

a. That Title 32, Signs, of the Code of the City of Portland, Oregon is amended and shall hereafter read as follows:

Section 32.20.240 Minimum Requirements for Structural Features.

- (e) All welding done within the scope of the sign industry shall be performed by welders certified in accordance with American Welding Society Standards for horizontal, vertical and overhead, mild steel welding and approved and registered with the Bureau of Buildings in conformance with sections 24.03.030(g) and 24.03.053, Building Regulations.
- Section 2. The Council declares that an emergency exists because this regulation is immediately required to insure that a potential for danger not be continued unnecessarily; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
