ORDINANCE No. 151393

An Ordinance amending Ordinance No. 151335, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways in front thereof for the one-month billing period ended January 31, 1981, by cancelling the assessment for Lot 6, Block 41, Tremont and E 10' of Lot 4, Block 22, Tremont Place, and reducing the total assessment by \$82.04, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 151335, assessed Lot 6, Block 41, Tremont \$18.70 and E 10' of Lot 4, Block 22, Tremont Place, \$65.34 for the repair and construction of sidewalks, curbs and driveways in front thereof for the one-month billing period ended January 31, 1981, and entered in the City Lien Docket Book 125, Page 61.
- 2. These liens were paid as invoices and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

a. Ordinance No. 151335 is amended by cancelling the assessment against Lot 6, Block 41, Tremont and E 10' of Lot 4, Block 22, Tremont Place by \$18.70 and \$65.34, respectively, and reducing the total assessment of \$23,721.92 to \$23,637.88.

Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurage; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
