

O R D I N A N C E N O. 151406

An Ordinance authorizing the transfer of \$250.00 from the Hydroelectric Power Construction Fund to the Electronic Services Operating Fund, increasing the appropriation of the Bureau of Electronic Services by \$250.00 for the purchase of a Pager, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Electronic Services is requiring the Bureau of Hydroelectric Power to replace a pager lost by the Bureau.
2. The Bureau of Hydroelectric Power has funds available in the 1980-81 Budget which may be allocated to this replacement.
3. A transfer of funds and increase in appropriation is necessary to allow purchase by the Bureau of Electronic Services for assignment to the Bureau of Hydroelectric Power.

NOW, THEREFORE, the Council directs:

- a. Funds are transferred and appropriation increased as follows:


ORDINANCE No.
