

ORDINANCE NO. 151423

An Ordinance amending Chapter 20.48 of the City Code relating to rates charged at St. Johns Racquet Center, effective May 1, 1981 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Parks operates the St. Johns Racquet Center within a separate self-sustaining enterprise fund.
2. The fee structure at the center is designed to generate revenues sufficient to pay operating expenditures when utilization reaches normal levels.
3. An increase in the playing rates is necessary in order to maintain the self-sustaining status of the fund in 1981-82 as projected in the 1981-82 budget process.
4. The code authority of the Commissioner-in-Charge of the Bureau of Parks and Recreation to establish special rates should be continued.
5. Chapter 20.48 of the City Code should be amended to reflect these adjustments effective May 1, 1981.

NOW, THEREFORE, the Council directs:

Section 1. Chapter 20.48 of the City Code is hereby amended to read as follows:

- (a) Same

- (d) The following rates shall be charged for the use of racquetball/handball courts at St. Johns Racquet Center:

For each 60 minute period:

Adults: \$2.50/player

Juniors: \$1.25/player

Season: \$32.50/player or \$65/court which ever is less

- (h) Same
- (i) The Commissioner-in-Charge of the Bureau of Parks and Recreation shall be authorized to establish special rates and periods of free play for tournaments, group use and other events not otherwise identified in this section and which are sponsored by the Bureau of Parks and Recreation.


Section 2. The rates and provisions established by this ordinance shall become effective on May 1, 1981.

Section 3. The Council declares an emergency exists in order that the benefits to be derived by the City through increased court fees may be realized without undue delay; therefore, with the special effective date of May 1, 1981, this Ordinance shall be in force and effect from and after its passage by the Council.
