ORDINANCE No. 151428

An Ordinance authorizing an amendment to Contract #19082 between the CITY OF PORTLAND and MULTNOMAH COUNTY acting by and through the Metropolitan Arts Commission (City), and Sharon Gilmore, (Artist), 2336 N.W. Pettygrove, #E, Portland, Oregon 97210, extending the completion date to June 30, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The City entered into Contract #19082 with Sharon Gilmore to provide four off-loom woven rope sculptures and three dance performances, to be completed March 31, 1981. The City agreed to provide space for the completed artwork by January 1, 1981.
- 2. A delay has occurred in locating an appropriate site, because of the size of the sculpture, requiring an extension of time.

NOW, THEREFORE, The Council directs:

- a. The Auditor and the Commissioner of Public Affairs to execute on behalf of the City an amending contract with Sharon Gilmore, 2336 N.W. Pettygrove #E, Portland, Oregon 97210, extending the completion date to June 30, 1981.
- b. This Ordinance shall be an effective amendment to Contract #19082, when the acceptance form has been signed by Sharon Gilmore, approved by the City Attorney and filed with the City Auditor.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the contract may unnecessarily deprive the citizens of Multnomah County and the City of Portland of the services being provided; therefore, this Ordinance shall be effective upon acceptance by Sharon Gilmore, in such form as provided by the City Auditor and approved by the City Attorney and after its passage by the Council, and declaring an emergency.
