ORDINANCE No. 151430

An Ordinance authorizing the Purchasing Agent to call for bids to paint the exterior of Marigold Tank for the Bureau of Water Works, authorizing a contract, authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

 The Bureau of Water Works requires that the exterior of of the one million gallon Marigold tank be painted pursuant to the on-going program for tank and reservoir maintenance.

NOW, THEREFORE, The Council directs:

- a. The Purchasing Agent shall advertise for bids using specifications filed in his office on April 14, 1981 and in the event that no satisfactory bid is received, shall advertise on the same basic specifications until a satisfactory bid is received.
- b. A contract is authorized with the most favorable bidder as designated by the Council.
- c. The Mayor and the Auditor hereby are authorized to draw and deliver a warrant chargeable to the 1980-81 Budget, Water Fund, BUC No. 18600374, Object Code 630, Project No. 3736, when demand is presented, approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in proceeding with the painting may result in additional expense and will unnecessarily deprive the City of benefits of completion of the contract at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
