

ORDINANCE No. 151431

An Ordinance amending Ordinance No. 150605, being an ordinance assessing upon certain property the cost of repairing and constructing sidewalks, curbs and driveways, in front thereof, for the one-month billing period ended August 31, 1980, by cancelling the assessment for Eastmoreland, Block 11, Lot 2, and reducing the total assessment by \$599.94, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance No. 150605, assessed Eastmoreland, Block 11, Lot 2, \$599.94 for the repair and construction of sidewalks, curbs and driveways in front thereof, for the one-month billing period ended August 31, 1980, and entered in City Lien Docket Book 124, Page 330.
2. This lien has been paid by interagency transfer of funds and should not be included in the assessment.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 150605, is amended by cancelling the assessment against Eastmoreland, Block 11, Lot 2, by \$599.94, and reducing the total assessment of \$20,765.69 to \$20,165.75.

Section 2. The Council declares that an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
