

ORDINANCE No. 151434

An Ordinance creating two positions of Criminalist and abolishing two positions of Police Detective within the Bureau of Police and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That two positions of Criminalist are required by the Bureau of Police.
2. That the Police Bureau, as a result of recent internal budget discussions, has changed its priorities in criminal investigations.
3. That the Criminalistics Division identifies over four hundred (400) suspects in crimes each year which result in a higher number of cases cleared by suspects admissions.
4. That with the addition of two Criminalist positions, up to one hundred thirty-five (135) additional felons will be identified through fingerprints.
5. That two positions of Police Detective may be abolished to provide appropriation for the positions being created.

NOW, THEREFORE, the Council directs:

- a. That two (2) positions of Criminalist (5175) are created with a salary rate in accordance with the current Compensation Plan and two (2) positions of Police Detective (5150) are abolished within the Bureau of Police.

Sections 2. The Council declares that an emergency exists because the positions to be created are immediately required in order that the new functions may be carried out without delay and the positions to be abolished should not be continued unnecessarily; therefore this Ordinance shall be in force and effect from and after its passage by the Council.
