ORDINANCE No. 151444

An Ordinance authorizing the appointment of Stephen D. Rees as Computer Services Director at a salary above the entry level for that position, to be effective April 20, 1981, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The position of Computer Services Director is required to recommend, execute and administer the data processing policies and programs adopted by the City Council.
- 2. The Council has determined that the qualifications of Stephen D. Rees, the individual selected for this position, are exceptional and that the demands of the position warrant compensation at a level above the entry rate.
- 3. The Bureau of Personnel has reviewed and approved this action.

NOW, THEREFORE, the Council directs:

- a. The Computer Services Director shall be compensated at the first year salary rate of \$19.81 per hour in accordance with the current salary plan, such compensation rate to be in effect retroactive to the April 20, 1981, date of appointment.
- Section 2. The Council declares that an emergency exists because authorization of this salary above the entry rate is required in order that the individual can be compensated in accordance with the level of duties performed as of April 20, 1981; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
