ORDINANCE NO. 151582

An Ordinance amending Contract No. 17716 with Dale R. Brunton, to increase the maximum contract fee by \$7,000.00 and the basic rate to \$192.50 per 8-hour day for negotiation and consulting services as required to purchase land and easements for the Groundwater Development Program, Bureau of Water Works, providing for acceptance, authorizing the drawing and delivery of warrants, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The City has entered into Contract No. 17716 with Dale R. Brunton to provide negotiation and consulting services required to obtain easements and property for the Groundwater Development Program, Bureau of Water Works. The work planned for this contract has been completed.
2. It is necessary and desirable to begin the right-of-way acquisition work for that portion of the east well field collection system west of N.E. 158th Avenue.
3. It is advantageous to the City to continue with the same consultant for this work because it will maintain continuity by utilizing a consultant already familiar with the project and the property owners in this area.
4. Negotiations with this consultant have been conducted with the result that both the consultant and the Bureau of Water Works are satisfied to continue services under Contract No. 17716 with an amendment to increase the maximum contract fee by \$7,000.00 and increase the basic rate to \$192.50 per 8-hour day to cover inflationary costs.
5. The selection of this consultant was made after review of proposals by a Consultant Selection Committee established in accordance with Chapter 5.68 of the City Code.
6. It will be necessary to waive Chapter 5.68 of the City Code, Professional Service Contracts, to allow this increase in the maximum contract fee.
7. These contract amendments, under the terms stated herein, were recommended by the Administrator of the Bureau of Water Works, and approved by the Commissioner-in-Charge.

ORDINANCE No.

NOW, THEREFORE, The Council directs:

- a. Contract No. 17716 with Dale R. Brunton is amended to increase the maximum contract fee by \$7,000.00 and the basic rate to \$192.50 per 8-hour day.
- b. Chapter 5.68 of the City Code is waived to allow said increase in the total contract fee without following a new consultant selection process.
- c. The amendment will not be effective until written notice of acceptance of the Ordinance by Dale R. Brunton is filed with the City Auditor.
- d. The Mayor and Auditor are hereby authorized to draw and deliver warrants chargeable to the 1980-81 Budget, Water Fund, BUC 18600374, Project 3700, Object Code 210, when demand is presented and approved by the proper authorities.

Section 2. The Council declares that an emergency exists because a delay in amending the contract may result in additional expense, and will unnecessarily deprive the City of the benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
