## ORDINANCE No. 151601

An Ordinance amending § 16.24.090, Driving, riding and hitching animals on sidewalk, of the Code of the City of Portland to exempt police animals, and cats, from purview of the section and declaring an emergency.

The City of Portland ordains:

Section 1. The Council Finds:

- 1. That is is necessary in the performance of official duties for police officers to occasionally take police horses and dogs onto public sidewalks.
- 2. That citizens of the City should be permitted to walk their domestic pet cats on public sidewalks.
- 3. That § 16.24.090, Driving, riding and hitching animals on sidewalk, prohibits both such activities and should be amended to allow same.

NOW, THEREFORE, the Council directs:

That § 16.24.090, Driving, riding and hitching animals on sidewalk, is hereby amended to read as follows:

16.24.090. Leading, driving, riding and hitching animals on sidewalk. It is unlawful for any person to lead, drive, or ride any animal, other than a dog or domestic pet cat upon any sidewalk, or to hitch or tie up any such animal upon any sidewalk or permit any such animal to stand thereon. This section does not apply to animals utilized by police officers in the performance of official duties.

Section 2. The Council declares that, in order to better protect and preserve the public peace, health and safety, an emergency exists, and this Ordinance shall be in force and effect from and after its passage by the Council.
