ORDINANCE No. 151613

An Ordinance repealing Ordinance No. 151333 which declared the building at 4036 N.E. 8th Avenue to be a public nuisance pursuant to Chapter 24.55 of the Code of the City of Portland and providing abatement by removal, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- On April 1, 1981, Ordinance No. 151333 was passed declaring the building at 4036 N.E. 8th Avenue, more particularly described as Lot 5, Block 19, LINCOLN PARK ANNEX in the City of Portland, Multnomah County, Oregon to be a public nuisance and providing abatement by removal.
- 2. Recently, Stephen Imeson acquired title to the subject property and has plans to completely rehabilitate the buildings.

NOW, THEREFORE, The Council directs:

a. Ordinance No. 151333 is repealed in its entirety.

Section 2. The Council declares:

That an emergency exists because delay in the enactment of this ordinance could result in unnecessary action by the Director of the Bureau of Buildings in abatement of the nuisance. Therefore, this ordinance shall be in force and effect, from and after its passage by Council.
