# ORDINANCE No. 151620

An Ordinance repealing Ordinance No. 149966, which granted the Republican Co. a revocable permit to use tieback shoring in the street area of S.W. 18th Avenue, S.W. Yamhill Street, and S.W. 17th Avenue adjacent to the west one-half of Block 321, Portland, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The Austin Co. had on behalf of the Republican Co. requested permission to use tieback shoring in the street area for construction of a building.
- 2. That the plans for construction of a new building were abandoned and the permit to use tieback shoring in the street area is no longer needed.

NOW, THEREFORE, the Council directs:

- a. Ordinance No. 149966 entitled "An Ordinance granting a revocable permit to the Republican Co. to use tieback shoring in the street area of S.W. 18th Avenue, S.W. Yamhill Street, and S.W. 17th Avenue adjacent to the west one-half of Block 321, Portland, and declaring an emergency." is hereby repealed.
- Section 2. The Council declares that an emergency exists in that there be no delay in clearing the records of unnecessary ordinances; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
