ORDINANCE NO. 151622 \$505

An Ordinance authorizing payment to John Douglas Holloway etux in the amount of \$50.00 and to Kathryn A. Blanchard in the amount of \$950.00 for damages to private property suffered in the course of construction of the SW Arnold Creek Sanitary Sewer System, and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- That in connection with acquisition of easements for the recently constructed SW Arnold Creek Sanitary Sewer System, certain trees and shrubbery in the construction area were purchased from various property owners to make it possible for the City's contractor to accomplish its work.
- 2. That it has been brought to the attention of the City Engineer that in two instances the City's contractor apparently felt it necessary to remove and did remove trees and shrubbery in excess of those purchased at the time of acquisition of sewer easements.
- 3. That John Douglas Holloway etux and Kathryn A. Blanchard, both of whom granted easements to the City for sewer construction have requested additional compensation in the amounts of \$50.00 and \$950.00 respectively in payment for the loss of trees and shrubbery for which they were not compensated at the time easements were purchased.
- 4. That payments in the amounts requested should now be made, and such amounts should be included in computing the total final costs of construction of the SW Arnold Creek Sanitary Sewer System.

### NOW, THEREFORE, the Council directs:

a. The Mayor and Auditor are hereby authorized to draw warrants in favor of the hereinafter named property owners in full payment for trees and shrubbery destroyed by the City's sewer contractor during construction of the SW Arnold Creek Sanitary Sewer System, and for which said owners were not earlier compensated, said payments in the amounts and in favor of the following:

John Douglas Holloway & Jodyne L. Holloway 2201 SW Palatine Street, Portland, Oregon 97219 Amount: \$50.00.

Kathryn A. Blanchard 12145 SW 33rd Avenue, Portland, Oregon 97219 Amount: \$950.00.

b. That delivery of warrants herein authorized shall be made after receipt by the Auditor of a written statement, approved as to form by the City Attorney, releasing the City and its contractor from any further liability for loss or damage to trees and shrubbery

on said owners property's resulting from the operations of the City or its contractor during the course of construction of the SW Arnold Creek Sanitary Sewer System.

- c. Said warrants are to be charged to the General Fund (43300016/490) Appropriations, Contributions and Advances to Improvement Districts, and it is further directed that the Mayor and Auditor draw and deliver a warrant in the total amount of \$1,000.00 to be credited to General Fund Revenue, said warrant to be drawn against and chargeable to the SW Arnold Creek Sanitary Sewer System Fund when created.
- Section 2. The Council declares an emergency exists, because early payment for damages to real property will avoid delay in determining the final total assessments for the construction of the SW Arnold Creek Sanitary Sewer System; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
