

An Ordinance amending Ordinances 151300, 151349 and 151350, to correct adjustments for grant funded projects: and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Ordinance 151300 requested a transfer of appropriations of \$3,636 from the Economic Planning Section - HCD II to the Bureau of Economic Development to make an adjustment for Industrial District Technical Assistance Grant No. 07-6-02127. Ordinance 151349 requested a transfer of appropriations of \$426 from the Economic Planning Section - HCD II to the Bureau of Economic Development to make an adjustment for the CEDS Coordination Grant No. 07-6-02128, and to make line item adjustments within the Economic Planning Section - HCD II appropriations for this grant. Ordinance 151350 requested a transfer of appropriation of \$18,671 from the Bureau of Economic Development to the Economic Planning Section - HCD II for the 302(A) Grant No. 07-25-01671-02, and to make line item adjustments for this grant within the Economic Planning Section - HCD II.
2. The appropriation actions of these ordinances cannot be implemented because they did not include the proper adjustments to the General, and Housing and Community Development Funds. Further, subsequent financial transactions require adjustments in the transfer accounts. Therefore, each of these ordinances must be amended.

NOW, THEREFORE, the Council directs:


