## ORDINANCE No. 151664

An Ordinance creating one position of Clerical Specialist I and abolishing one position of Secretarial Clerk I within the Bureau of Police, Internal Affairs Division, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That one position of Clerical Specialist I is required by the Bureau of Police.
- 2. That the Bureau of Police has requested that the position of Secretarial Clerk I be reclassified to the position of Clerical Specialist I and the Civil Service staff has approved the request.
- 3. That the reclassification action will be placed on the June, 1981 agenda of the Civil Service Board for formal approval.
- 4. That one Secretarial Clerk I position can be abolished to provide partial appropriation for the position being created and the necessary additional appropriation will be provided by salary savings within the Internal Affairs Division.

NOW, THEREFORE, the Council directs:

a. That one position of Clerical Specialist I (0114) is created with a salary rate in accordance with the current Compensation Plan and one position of Secretarial Clerk I (0220) is abolished within the Bureau of Police, Internal Affairs Division.

Section 2. The Council declares that an emergency exists because the position to be created is immediately required in order that the new functions may be carried out without delay and the position to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
