ORDINANCE No. 151668

An Ordinance authorizing a contract in the amount of \$36,000 with Mid-Oregon Warehouse, Inc. to furnish single and double cylinder deadbolt lock sets to the Bureau of Police for assignment to said Bureau, authorizing the drawing and delivery of a warrant(s) and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That Mid-Oregon Warehouse, Inc. was the lowest responsible bidder for said lock sets for the Bureau of Police.
- 2. That award of a contract to said bidder for completing said project has been recommended and approved by the Commissioner in Charge.

NOW, THEREFORE, the Council directs:

- a. The Auditor and the Commissioner of Public Safety hereby are authorized to execute a contract in the amount of \$36,000 with the responsible bidder for the items described in Section 1 hereof in accordance with specifications filed with the Purchasing Agent.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrant(s) chargeable to the 1980-81 Budget; General Fund, Bureau of Police (10100062.320), when demand is presented, approved by the proper authorities.
- Section 2. The Council declares that an emergency exists because a delay in proceeding with the purchase may result in additional expense, and will unnecessarily deprive the City of benefits of completion of the contract at an early date; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
