

ORDINANCE NO. **151670**

An Ordinance authorizing acceptance of a grant from the State of Oregon in the amount of \$44,184; increasing the Federal Grants and the General Fund, creating one position for the implementation of the City of Portland Refugee Coordinator Program and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The City Council by Ordinance No. 151159, authorized a grant application to the State of Oregon in the amount of \$69,607 for the City of Portland Refugee Coordinator Program.
2. The State of Oregon has made an offer of a grant in an amount not to exceed \$44,194 for a 12 month period to aid the City in the implementation of a program to assist in the refugee resettlement effort and to coordinate with others who are providing resettlement services.
3. Total direct cost of the one year project is \$44,194. There is no local match required. There is no eligible indirect cost reimbursement.
4. Acceptance by the City of the grant is required before grant funding can be utilized.
5. The position of Refugee Coordinator is required to perform the activities of the grant and to supervise the half-time Typist Clerk who will provide clerical support to the project.
6. Appropriation required in FY 80-81 for implementation of the program is \$2,899. The balance of the grant amount, \$41,285, will be appropriated in FY 81-82.
7. The new position and its salary rate has been approved by the Bureau of Personnel Services.

NOW, THEREFORE, the Council directs:

- a. The Mayor and the Commissioner in Charge are hereby authorized to accept on behalf of the City an offer of grant in an amount not to exceed \$44,184 for a 12 month period from the State of Oregon for the implementation of the City of Portland Refugee Coordinator Program.

b. The 1980-81 City Budget is hereby amended as follows:
