An Ordinance transferring \$21,488 within the Housing and Community Development Fund and the General Fund to increase appropriation in the Office of the Auditor for advertising and assessment fees for HCD street improvement projects; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- That the Office of the Auditor incurs expenses for assessment and advertising for Housing and Community Development (HCD) street improvement projects.
- 2. That \$36,000 was appropriated in the HCD fund for FY 80-81 to cover these costs.
- 3. That actual costs for FY 80-81 will be \$57,488.
- 4. That it is appropriate for the Housing and Community Development Fund to cover these costs.
- 5. That it is necessary to transfer \$21,488 within the HCD Fund and the General Fund and increase appropriations in the Office of the Auditor.
