

ORDINANCE No. 151699

An Ordinance transferring \$9,977.50 from General Fund Operating Contingency to the Office of General Services for professional services related to the development of a condominium ownership of the Justice Center by the City and Multnomah County, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. That the Justice Center now under construction will be jointly occupied by the City and Multnomah County.
2. That the Justice Center is being constructed on land jointly owned by the City and Multnomah County, and that title to the structure and management responsibilities must be assigned.
3. That the specialized services of an attorney and a surveyor are required to prepare the documents necessary to establish the Justice Center as a condominium.
4. That the costs for these services will be jointly shared by the City and County.
5. That it is necessary to transfer appropriation in the amount of \$9,977.50 from General Fund Operating Contingency to the Office of General Services to pay the City's share of the professional service costs.

NOW, THEREFORE, The Council directs:

- a. Appropriations are transferred as follows:

Section 2. The Council declares that an emergency exists because a delay would place an undue administrative burden on the City; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
