



We are proud to announce a partnership between the City of Portland and Multnomah County. Together, we aim to pool fiscal resources to address the houselessness crisis.




Yesterday, I joined Commissioner Ryan and Chair Kafoury to share our proposed partnership which will combine City and County fiscal resources to address the houseless crisis. As leaders in our community, we recognize the severity of this problem. Residents have lacked safe and affordable housing for years, only worsened by the effects of COVID-19. As the houseless crisis has accelerated, we have seen an increase in violence, mental health issues, and a decline in livability standards.

The City of Portland and Multnomah County have already allocated funding to address houselessness though our own annual budget processes; however, business taxes collected by the City and County exceeded expectations leaving us both with a surplus of funding.

We know that our impact will be greater when we work together. After much discussion, we have agreed to pool our resources, totaling \$38 million to collectively invest in initiatives that will address the houselessness issue.


