Testimony to **Portland City Council** on the **Shelter to Housing Continuum Project**, **Recommended Draft**

The idea of allowing temporary shelters beyond the current tent/camping situation in Portland City Parks would be a complete and utter mess. The City of Portland is not able to manage the current situation regarding homelessness/"rooflessness", and now they are dumping the mess into our City Parks, which we all will pay for in many ways. There is already a major health and safety issue with people camping and loitering in the parks and squares in the NW portion of the city, and this will only escalate the problem. I ask the following questions for the City of Portland: Where in the U.S. has long-term medical care, mental care, and housing been SUCCESSFULLY provided to those in need, and how can Portland follow this example? What sort of partnerships has the City of Portland developed with local/regional nonprofits, faith based organizations, and the State, and Federal programs so that the City of Portland's actions and programs regarding homelessness can be addressed and curtailed over the long term? How can the City of Portland moved beyond its Permissive Political Correctness regarding the City's homeless/roofless population and create and maintain a city that does not have temporary shelters and tents in close proximity with rats running around the area, needles scattered around these camping sites, and people who physically threaten and chase City of Portland residents (and tax payers) who walk through public areas such as Parks and Squares?
