- Far Right groups chose Portland for another rally because of our City's professed progressive, multi-cultural values, and because of our Police Bureau's history of preferential treatment for groups like theirs.
- In the previous months, PPB used violent tactics to clear out antifascist protesters opposing the presence and tactics of groups like the ones gathering on August 4, 2018. While antifascists met violence, the Far Right met deference.

What kind of deference?

The day before the rally, Gibson posted a video with instructions for would-be rallygoers to find the plaza. Alternatively, participants could catch one of the yellow school buses Patriot Prayer deployed to bring attendees to the rally. He said the plan was to gather at Schrunk Plaza, noting no weapons would be permitted. But he reassured participants that "security" would be stationed outside the rally point with guns.



Gibson's speech at some points became militant. He went on at length about George Washington and how he led his men to war.

"Before you know it, it's going to be too late, and then the guns are going to have come out," he said. "And then we're going to have make the same sacrifices our forefathers made."

Another speaker, California "alt-lite" figure Haley Adams, disparaged Portland and its mayor. "We don't have to leave the country to see a shithole, because you're standing in a shithole today!" Adams told the audience.







On 08/06/2018 the Independent Police Review (IPR) received your complaint about the conduct of unidentified Portland Police Bureau Officers during an August 4, 2018, protests where you received a serious injury. IPR initiated its investigation prior to your legal counsel filing a tort claim against the Police Bureau but details included within it provided the assigned IPR investigator information that was useful to this investigation.

During our inquiry IPR staff reviewed police reports, many hours of video, witness statements, and dispatch records related to the incident. Unfortunately, IPR was unable to interview you during this investigation. Despite our best efforts, IPR was unable to identify an involved officer and will administratively close this investigation.

Your complaint is stored in a database that we use to analyze patterns of conduct as they emerge over time. These reviews help us to improve the quality of police services to the community in the long term. Thank you for your contribution to our effort.
