





Support meaningful involvement of Superfund-impacted communities that results in greater public participation in the cleanup process and community informed decision-making.

Program Background

- Launched community involvement program in 2019
- City Council authorized \$300K through FY23-24 to support community involvement
- Focused grantmaking in FY20-21
 - 5 awards totaling \$80K
 - Cohort model
 - New collaborations
 - Mutual learning



Ordinance Amendment

- Authorizes \$1.5m for community grants and grants administration
- Extends funding through remedial design phase
 - FY24-25
- Authorized funds will support all Portlanders, particularly those disproportionately affected by the Portland Harbor Superfund Site contamination and cleanup
