

An Ordinance amending the Compensation Plan by abolishing the classification of Budget Officer (0831) and Finance Officer (0535), creating the classification of Director of Fiscal Administration (0831), establishing a rate of pay effective December 10, 1980

The City of Portland ordains:

Section 1. The Council finds:

1. On December 10, 1980, the Mayor merged the Budget Office and the Bureau of Financial Affairs into the Office of Fiscal Administration to increase operating efficiency and improve the city's financial services.
2. The Director of Fiscal Administration was assigned responsibility for coordinating the operations of the financial and budget activities of the city and for performing the duties of Budget Officer, Finance Officer, and Chief Deputy City Treasurer.
3. The Bureau of Personnel Services has reviewed the Director of Fiscal Administration position and the Civil Service Board recommends the Compensation Plan be amended by abolishing the classification of Budget Officer (0831) and Finance Officer (0535), and establishing the classification of Director of Fiscal Administration (0831) at a new rate of pay.
4. No additional appropriation is required to fund this position for the 1980-81 fiscal year.

NOW, THEREFORE, the Council directs:

- a. The Compensation Plan is hereby amended by abolishing the following classifications:

- b. The Compensation Plan is hereby amended by establishing the new classification of Director of Fiscal Administration at the following rate of pay:

- c. The effective date for the Compensation Plan amendments and new rate of pay is December 10, 1980.
