

ORDINANCE No. 151805

An Ordinance transferring appropriations within the Housing and Community Development Economic Planning Section Appropriation Unit 538 to correct overexpenditures; and declaring an emergency.

The City of Portland ordains:

Section 1. The City Council finds:

1. Appropriation Unit 538 is overexpended in personal services for Fiscal Year 1980-81.
2. These overexpenditures are a result of erroneous appropriation transfers made subsequent to the creation of Appropriation Unit 538 in January of 1981.
3. The overexpenditure needs to be corrected in order to comply with state budget law.
4. Sufficient appropriation exists within the Appropriation Unit 538 budget to cover the overexpenditure.

NOW, THEREFORE, the Council directs:

- a. The Fiscal Year 1980-81 City budget is hereby amended as follows:
