ORDINANCE NO. 151809

An Ordinance amending the Fiscal Year 1981-82 budget by transferring appropriations within the Housing and CommunityDevelopment Fund and the General Fund to provide support for the Office of Housing Policy, effective July 1, 1981; creating positions in the Office of Housing Policy, effective July 1, 1981; abolishing positions in the Bureau of Planning; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Appropriation in the amount of \$120,750 is needed to support the newly established Office of Housing Policy for Fiscal Year 1981-82.
- Housing and Community Development funds in the amount of \$91,190 are available from the Fiscal Year 1981-82 Bureau of Planning Housing Section budget with the balance of \$29,560 to be provided by the Housing and Community Development Contingency.
- 3. Two full-time positions need to be transferred from the Bureau of Planning and one full-time position needs to be created to staff the Office of Housing Policy.

NOW, THEREFORE, the Council directs:
