

# ORDINANCE No. 151811

An Ordinance transferring \$209.00 within the General Fund from General Fund Operating Contingency to the Special Appropriation Assessments for Improvements to provide for payments of assessments against City-owned property; and declaring an emergency.

The City of Portland ordains:

Section I. The Council finds:

1. The Special Appropriation in the General Fund to pay assessments for Improvements was budgeted \$53,500 in 1980-81.
2. Expenditures for Assessments for Improvements to benefiting City-owned property has exceeded the current appropriation by \$209.00.
3. An additional appropriation in the amount of \$209.00 should be provided from General Fund Operating Contingency.

NOW, THEREFORE, the Council directs:

- a. The sum of \$209.00 is hereby transferred within the General Fund as follows:

Section 2.
