ORDINANCE NO. 151814

An Ordinance transferring \$11.546 within the General Fund from General Operating Contingency to the Metropolitan Arts Commission for administration of the 1% for Art Program, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. The new city office building construction budget includes \$222,000 for permanent art.
- 2. The attorney for the Public Buildings Corporation has advised that the construction funds cannot be used for administrative purposes.
- 3. The Metropolitan Arts Commission is the appropriate agency to administer the competition and selection of art. They will be responsible for: administering the 1% for Art Program, including coordination with users, contracting agencies. the commission, the city, and artists; providing public information; keeping records of all funds expended in the program; and researching various components relating to the 1% for Art Program.
- 4. Funds in the amount of \$11,546 for said purpose should be transferred from General Operating Contingency to the Metropolitan Arts Commission.

NOW, THEREFORE, the Council directs:

a. \$11,546 is transferred within the General Fund from General Operating Contingency to the Metropolitan Arts Commission's 1981-82 budget as follows:
