ORDINANCE NO.

An Ordinance authorizing the Purchasing Agent to obtain informal bids and to to sign a Purchase Order to serve as a contract to the most acceptable bidder for <a href="SEAT COVERING MATERIAL">SEAT COVERING MATERIAL</a> for the Exposition-Recreation Department, at an amount not to exceed \$70,000.00, the drawing and delivery of warrants, waiving performance bond requirements and declaring an emergency.

The City of Portland ordains:

### Section 1. The Council finds:

- 1. That the Exposition-Recreation Department requires seat covering material for the completion of a seating renovation project currently programmed for August of 1981.
- 2. That the seat covering materials are urgently needed to allow the Exposition-Recreation Department to take advantage of available Summer Youth Work, labor sources at a substantially reduced labor cost.
- 3. That the scheduling of the Exposition-Recreation Department Arena is such that only an August 1981 time period exists in which to properly complete the seat renovation project.
- 4. The Purchasing Agent should obtain informal bids and sign a purchase order to serve as a contract for seat covering materials mentioned in Section 1. at an estimated cost not to exceed \$70,000.00.

## NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall obtain informal bids and sign a purchase order to serve as a contract with the most acceptable bidder for approximately 8,968 fabricated seat covers as mentioned in Section 1., for an estimated cost not to exceed \$70,000.00.
- b. The Mayor and the Auditor hereby are authorized to draw and deliver warrants chargeable to the 1981-82 Budget; Exposition-Recreation Fund, Object Code 630, Improvements, when demand is presented, approved by the proper authorities.

## Section 2. The Council declares:

An emergency exists because a delay in proceeding with the purchase may result in additional expenses and will unnecessarily deprive the City of the benefits of completion of the project at an early date; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
