

An Ordinance creating one position of Commissioners Assistant III, abolishing one position of Justice Planning and Evaluation Director and one position of Secretarial Clerk I in the Commissioner of Public Safety's FY 81-82 budget, effective July 1, 1981; and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. One position of Commissioners Assistant III is required by the Commissioner of Public Safety. This position is required to assist in the liaison to programs operated by the Commissioner of Public Safety and to do research, program development and liaison as assigned.
2. The position of Justice Planning and Evaluation Director and the position of Secretarial Clerk I are no longer required in the Commissioner of Public Safety's Office.
3. There is no increase in costs in the FY 81-82 budget because the abolished positions provide the resources for the position to be created.
4. These changes have been approved by the Bureau of Personnel Services.

NOW, THEREFORE, the Council directs:

- a. The following position is created in the Office of the Commissioner of Public Safety, effective July 1, 1981, with the salary rates in accordance with the current Compensation Plan:

Section 2. The Council declares that an emergency exists because the position to be created is required immediately in order that its function may be carried out without delay, and the positions to be abolished should not be continued unnecessarily; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
