

ORDINANCE NO. 151823

An Ordinance amending the FY 1980-81 budget for the Metropolitan Human Relations Commission by transferring appropriation of \$4,500 within the General Fund from General Operating Contingency to Metropolitan Human Relations Commission to pay printing costs, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds;

- 1. Metropolitan Human Relations Commission (MHRC) has incurred printing expenses in excess of amounts anticipated in the FY 1980-81 budget.
- 2. In the Third Quarter Allotment Ordinance No. 151696, MHRC returned personal services savings of \$8,932 to General Operating Contingency.
- 3. The additional appropriation required should be provided by a transfer from General Operating Contingency to MHRC materials and services.

NOW, THEREFORE, The Council directs:

a. The FY 1980-81 budget for MHRC (341) is hereby amended as follows:
