ORDINANCE NO.

151833

An Ordinance transferring \$320,230 within the General Fund from General Fund Operating Contingency, Unforeseen Reimbursable Expenditures, to the Bureau of Computer Services and transferring \$2,700 within the Bureau of Computer Services in order to prevent an overexpenditure at the end of FY 1980-81, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. That for various reasons, several major projects undertaken by the Bureau of Computer Services have fallen behind schedule.
- 2. That costs to be incurred by the Bureau of Computer Services in FY 1980-81 have significantly exceeded initial estimates.
- 3. That the budget of the Bureau of Computer Services does not contain sufficient appropriation to cover projected expenditures for FY 1980-81.
- 4. That it is necessary to transfer \$2,700 within the budget of the Bureau of Computer Services and to transfer \$320,230 from General Fund Operating Contingency to the Bureau of Computer Services to meet the projected deficit.

NOW, THEREFORE, The Council directs:
