#### Public comment:

David Burchfield – re: heat response equipment purchasing partner (EPP) memo. Expressed concern about the scoring results versus the staff recommendation to Committee.

# Heat response program, equipment purchasing partner (EPP) proposal overview – by Jaimes Valdez and Sam Baraso

Staff provide overview of process, proposals received, scoring, and staff recommendation along with alternative recommendation.

Brief comments following staff presentation shared by

David Heslam – Executive Director of Earth Advantage, EPP applicant

- Noted that everyone was surprised by the heat event and appreciation for PCEF for responding
- Provided a review of their work history and role in the building energy use space
- Can provide support role in cost effective way

Linda Woodley – Executive Director of Diversifying Energy, EPP applicant

- We could have had an all-Black team. We have the ability and capability.
- The issue seems to be the pricing. There is an urgency to get the units out. Believe we can do it in three years.

#### **Committee member discussion**

- Robin Questions about 3 year versus 5-year timelines.
- Ranfis Expressed respect for the proposals and requested to take more time to get more detailed information.
- Megan Feeling confused about getting two different recommendations. Feels like she doesn't have complete information to make decision. The scoring criteria and process is messy.
- Michael Excited about both proposals. Spoke to community members after reading memo. This
  is our biggest request to date. Following guiding principles is a major concern. Community
  members also expressed concern.
- Robin Acknowledges and appreciates Michael's comments. Goes back to the integrity of the process, if we deviate from the score now, it could impact integrity of scoring in future.
- Maria Shares lots of the sentiments shared by others. The process is messy not the people. Not sure what additional information I could want that would help me to make this decision.
- Jeffrey Appreciation to applicants. Agree with others about integrity and the optics of this. Scoring is not perfect, and we are a young committee, it is too early for our integrity to be questioned by deviating from scoring.

- Shanice Adding this piece to our work to be responsive, talking about a few million dollars, illustrates a need to have more employee capacity dedicated to PCEF - in this context and just overall
- Ranfis I won't be a barrier to where the Committee is leaning on this, but not comfortable
  voting. Concerns about integrity, willing to meet next week if that's needed. This is a messy
  process but that shouldn't stop us from asking questions about how they will perform. I don't
  feel like I am equipped to make a decision. It takes a lot for staff to say that there are major
  concerns here and that is why we are making this recommendation, despite the scoring.
