

ORDINANCE No. 151872

An Ordinance authorizing the permanent appointment to the position of Youth Service Center Coordinator/HR Coord. I (7460) within the Bureau of Human Resources, AU 380, at a rate higher than the entry rate, effective July 1, 1981 and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. With the approval of FY 81-82 City Budget, the position of HR Coord II/ Youth Service Center Coordinator was reclassified to an HR Coord I.
- 2. Sarah Newhall, the incumbant in the position, has held the position for the past five years and possesses the experience and skills that justify her appointment at a salary rate of after three years.
- 3. Sufficient funds have been budgeted to accomodate this action and no additional funds are required.
- 4. It is therefore appropriate that Sarah Newhall be permanently appointed to the position of HR Coord I/Youth Service Center Coordinator (7460) within the Bureau of Human Resources at a salary rate higher than the entry rate effective July 1, 1981.

NOW, THEREFORE, the Council directs:

- a. One HR Coord I/Youth Service Center Coordinator (7460) position within the Bureau of Human Resources, be permanently filled by Sarah Newhall at a salary rate in accordance with the current compensation rate at a level of after three years, effective July 1, 1981.

Section 2. The Council declares that an emergency exists in order to properly compensate the individual in the Bureau of Human Resources for duties and responsibilities assigned; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
