

ORDINANCE No. 151873

An Ordinance abolishing one (1) HR Specialist III (7457) and creating one (1) HR Specialist II (7456) within the Human Resources Bureau, AU 380, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. Pursuant to the approval of FY 1981-82 City Budget, one (1) HR Specialist III position was authorized to serve as staff to the newly created Portland/Multnomah Commission on Aging.
2. The Civil Service Board has reviewed the duties, knowledge, and skills associated with the position and has determined that the classification of HR Specialist II is more appropriate.
3. It is therefore appropriate that one (1) position of HR Specialist III (7457) be abolished and one (1) HR Specialist II (7456) be created within the Human Resources Bureau.

NOW, THEREFORE, the Council directs:


- a. That one (1) position of HR Specialist III (7457) be abolished and one (1) position of HR Specialist II (7456) be created within the Human Resources Bureau, AU 380, at a salary rate in accordance with the current compensation plan of the City of Portland.

Section 2. The Council declares that an emergency exists because delay in enactment of this Ordinance will result in unnecessary problems in the administration of programs; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.
