

# ORDINANCE No. 151889

An Ordinance transferring \$7,700 from the General Fund - General Operating Contingency to the Fleet Operating Fund for the purchase of a vehicle for the Office of Emergency Services, increasing appropriations in the Fleet Operating Fund and Bureau of Fleet Management, and declaring an emergency.

The City of Portland ordains:

SECTION 1. The Council finds:

1. The Office of Emergency Services requires a sedan in order to comply with 24 hour on-call status in responding immediately to emergencies.
2. Since this need is outside the scope of the normal replacement program, a transfer is required to fund their purchase.
3. The vehicle will be purchased as soon as possible.

NOW, THEREFORE, The Council directs:


