

ORDINANCE No. 151902

An Ordinance reclassifying one position of Clerical Specialist I to one position of Clerical Specialist II in the Bureau of Water Works.

The City of Portland ordains:

Section 1. The Council finds:

1. The responsibilities assigned to one position of Clerical Specialist I in the Permit Section of the Bureau of Water Works has increased sufficiently to necessitate reclassification.
2. One position of Clerical Specialist II is required by the Bureau of Water Works to more closely compensate for the duties and responsibilities of the position.
3. One position of Clerical Specialist I should be reclassified to Clerical Specialist II.
4. This change has been reviewed and approved by the Bureau of Personnel Services.

NOW, THEREFORE, The Council directs:

- a. One position of Clerical Specialist I (0114) is reclassified to Clerical Specialist II (0117) with salary rates in accordance with the current compensation plan.
