

## ORDINANCE NO. 151913

An ordinance authorizing the Purchasing Agent to sign a Purchase Order as a contract with Cummins Oregon Diesel, 2257 NW Vaughn, Portland, Oregon for repairs to a diesel engine on Fire Boat 2 for the Bureau of Fire at the estimated amount of \$35,000 without advertising for bids, authorizing the transfer of \$35,000 within the General Fund, from the Operating Contingency, to the Bureau of Fire, authorizing the drawing and delivery of a warrant and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

1. The Bureau of Fire requires immediate repairs to a diesel engine on Fire Boat 2 (David Campbell). The engine has blown a hole in its block thereby placing the boat out-of-service until repairs can be effected. Fire Boat 3 (Virgil Spencer) is also currently out-of-service undergoing repairs.
2. The repairs to Fire Boat 2 are urgently necessary for the public welfare and the time for advertising would result in delay improper in the circumstances because a deficiency exists in the provision of suppression services on the Willamette River and adjacent property due to two fire boats currently being out-of-service.
3. This purchase has been reviewed and approved by the Purchasing Agent. It is therefore in the public interest for Cummins Oregon Diesel to provide the necessary materials and services as set forth above at an estimated cost of \$35,000 without advertising for bids.
4. The Bureau of Fire does not have sufficient appropriation within its FY 1981-82 budget for this expenditure thereby necessitating a transfer from the General Fund Operating Contingency.

NOW, THEREFORE, the Council directs:

- a. The Purchasing Agent shall sign a Purchase Order to serve as a contract with Cummins Oregon Diesel, 2257 NW Vaughn, Portland, Oregon for repair services described in Section 1, for the total estimate of \$35,000 without advertising for bids.

- b. The Mayor and the Auditor are hereby authorized to draw and deliver a warrant chargeable to the FY 81-82 budget, General Fund, Bureau of Fire (AU 124) Logistics Division (12400039), Object Code 240, when demand is presented, approved by the proper authorities.
- c. The FY 1981-82 City of Portland Budget is amended as follows:

Section 2. The Council declares that an emergency exists because a delay would deprive the City of the benefits derived from the services provided by Fire Boat 2; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
