ORDINANCE No.

An Ordinance amending Ordinance No. 150804, being an ordinance assessing upon certain property the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended September 30, 1980 and authorizing a refund of \$75.00 to Catherine Sewell, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Ordinance No. 150804, assessed Bowne Addition, Lot 14, \$206.32 for the cost of abating and removing certain nuisances, including a fee for administration expenses for the one-month billing period ended September 30, 1980, and entered in the City Lien Docket Book 124, Page 345.
- 2. The property owner paid the full amount of the assessment but requested a hearing before the Jouncil concerning the matter. At the Council meeting on July 2, 1981, Council Calendar No. 2211, the Council directed the lien be reduced by \$75.00.

NOW, THEREFORE, the Council directs:

- a. Ordinance No.150804 is amended by reducing the assessment against Lot 14, Bowne Addition, by \$75.00 and reducing the total assessment of \$4,873.49 to \$4,798.49.
- b. The City Auditor is authorized to draw and deliver a warrant in the amount of \$75.00 to Catherine Sewell, 5717 SE Mitchell, Portland, Oregon 97206, chargeable to Buc No. 40600264.
- Section 2. The Council declares an emergency exists because of the necessity of keeping the City's financial records accurate; therefore, this ordinance shall be in force and effect from and after its passage by the Council.
