ORDINANCE NO. 151947

An Ordinance accepting a street deed for the SE Lents Street Improvement Project District II, granted by Denton Faye Hartung, authorizing total payment of \$1070.00, and declaring an emergency.

The City of Portland ordains:

Section 1. The Council finds:

- 1. Right of way is required for construction of the SE Lents Street Improvement Project District II.
- 2. Denton Faye Hartung has conveyed the required right of way to the City for the total sum of \$1070.00.

NOW, THEREFORE, the Council directs:

- a. That the following described tract is hereby accepted for street purposes:

R/W #3728-1

The north 5.0 feet of Lot C, Block 2, Gordon Place, in the City of Portland, County of Multnomah, State of Oregon. (Granted by Denton Faye Hartung).

- b. The Mayor and Auditor to draw and deliver a warrant in payment for the above described tract in the amount and in favor of the following:

Grantor: Denton Faye Hartung Amount: \$1070.00

Address: 8310 SE Bybee Blvd., Portland, Oregon 97266

said warrant to be charged to BUC 15923300 (Job #6006) and will be 100% reimbursed by the Housing and Community Development Fund.

- c. The Auditor shall record in the appropriate deed records, documents of title as necessary for purchase of this right of way.

Section 2. The Council declares that an emergency exists because a delay in the acceptance of the street deed might result in delays in construction; therefore, this Ordinance shall be in force and effect from and after its passage by the Council.


